**NOTICE OF ELECTION OF TEN MEMBERS OF THE  
EXECUTIVE COMMITTEE OF THE SENIOR CITIZENS COUNCIL  
FOR THE PERIOD 2025 – 2027**  
**[COMPRISING TWO MEMBERS FOR DISTRICT OF PLAINES WILHEMS**  
**(i.e. one for Lower Plaines Wilhems Ward and one for Upper Plaines Wilhems Ward)**  
**AND ONE MEMBER FOR EACH OTHER DISTRICTS]**

Notice is hereby given to all Senior Citizens Organisations registered with the Registrar of Associations and affiliated with the Senior Citizens Council that the election of one (1) representative of member organisations for Lower Plaines Wilhems Ward, Upper Plaines Wilhems Ward and for each of the eight (8) other districts of Mauritius to the Executive Committee of the Senior Citizens Council for the period 2025 – 2027 will be conducted by the Office of the Electoral Commissioner on **Saturday first (1<sup>st</sup>) day of March, 2025**; and that the Returning Officer for each district/ward will receive the nomination of candidates for the said election on **Saturday the eighth (8<sup>th</sup>) day of February, 2025**, between the hours of **9 a.m. and 12 noon** at the “Nomination Centre” respectively shown opposite each district/ward in the schedule below:

Forms of nomination paper may be obtained at the Office of the Electoral Commissioner, Level 4 MaxCity Building, Corner Rémy Ollier & Louis Pasteur Streets, Port Louis, or from the Head Office, Senior Citizens Council, 2<sup>nd</sup> Floor, Block A, Astor Court, Lislet Geoffroy Street, Port Louis between the hours of 10 a.m. and 3 p.m. on working days (excluding Saturdays).

## NOTE:

- (A) a member organisation, with the approval of its Executive Committee, can delegate only **one** representative to stand as candidate; and
- (B) the candidate for a district/ward must
  - (i) belong to a member organisation whose seat is **in that district/ward**;
  - (ii) have been a resident of that district/ward for the six months preceding the Nomination Day for this election; and
  - (iii) have been a member of the said organisation whose seat is in that district/ward for the six months preceding the Nomination Day for this election.

Every nomination paper must **also** be sponsored by the President or Secretary of the candidate's organisation and supported by **at least two OTHER members** of the organisation; and must be delivered to the Returning Officer between the said hours of 9 a.m. and 12 noon on **08 February 2025**.

The President or Secretary of the said organisation should also certify, on the Nomination paper, that the candidate: -

- (i) has been a resident of that district/ward for the six months preceding the Nomination Day for this election; and
- (ii) has been a member of the said organisation of that district/ward for the six months preceding the Nomination Day for this election.

Every nomination paper shall specify

- (a) the name and address of the candidate;
- (b) the name and address of the seat of the organisation to which he/she belongs; and
- (c) the name and address of the President or Secretary of the said organisation.
